4. Copy of PHRF or GLMRA Rating Certificate, if available.
5. Check for \$230 (\$200 for current dues paid GLSS members) in U.S. funds payable to GLSS (Include \$50 late entry fee if received after August 1st, 2008).
6. Life raft inspection certificate must be submitted no later than August 22<sup>nd</sup>, 2008.

Attach a copy of your PHRF or GLMRA Rating Certificate. If you do not have a rating, please complete the following information. If you do not have a current PHRF/GLMRA certificate or one issued within the previous three years, a six second/mile penalty will be imposed. Any omitted data can result in the race committee completing the data to the best of their ability. No requests for rating changes will be accepted after August 1st, 2008.
